Please note the updates regarding the following services:

# **Closure of home-based daycares**

- The Prescott and Russell Licensed Home Child Care Agency will close the home-based daycares, effective at the end of the day on Tuesday, March 17, 2020;
- Home-based daycares will remain closed from March 18 until April 5, inclusively, as per the recommendation from the Ministry of Health.
- Clients will not be billed for these days and these closures come without any cost to parents.

# **EarlyON Child and Family Centres**

- The EarlyON Centre in Rockland is closed as of Tuesday, March 17, 2020.
- All programs offered in the community by the EarlyON Child and Family Centres are cancelled for an undetermined period of time.

## Administrative building (L'Orignal)

 The UCPR Administrative building remains closed for the majority of services, except for emergency cases regarding Ontario Works and Housing Services.

## **Ontario Works**

The Ontario Works office in Rockland is closed.

## PR Transpo

 The PR Transpo commuter transportation service has been suspended indefinitely, until further notice.

## **Emergency Services and Ambulance Bases**

- The Emergency Services administrative office in Plantagenet is closed.
